Vocational Nursing Registration Requirements:

- Enrollment \$250.00 non-refundable deposit, enrollment balance due at appointment
- Valid Government ID, Social Security Card
- 18 years of age or older and high school diploma or GED Certificate or equivalent is a requirement for all enrolling students.
- Must have an active Certified Nurse Assistant License, issued by CDPH.
- Pass a TEAS entrance exam: Score 60 within 12-months of start date OR a score of 65 within 36- months of start date. Link to register for TEAS exam
- (2) Letters of recommendation from healthcare professional co-workers (Management level)

Student Records Requirements (Due 30 days prior to program start date):

- Physical exam by Physician/Nurse Practitioner on FLP Form (Within 90 days of program)
- QuantiFERON TB Gold Blood Test or Chest X-ray (Must be valid duration program)
- Vaccine Record: MMR Titers or 2 doses of MMR vaccine, Varicella Titers or 2 doses of Varicella vaccine, Hepatitis B Immunization or signed declination, TDAP within (10) years
- (2) Negative 10 Panel Drug Screens (Within 30 days of program/ random 2nd or 4th term)
- Flu Vaccine (During flu season October – March), Covid-19 vaccination card or waiver
- Background Check: Social security number verification, criminal search (7 years), Sex Offender search/ Clearance of convictions "Mybackgroundcheck.com (Student Version)
- Malpractice Insurance through NSO (required for clinical)

Remaining balance due AT ORIENTATION DATE, or you must sign a payment plan contract.
